Kane Wommack was named the head football coach at the University of South Alabama on Dec. 12, 2020. At 34 years old, he becomes the third head coach since the inception of South's program and the youngest of any head coach at the FBS level. Kane and his wife, Melissa, returned to Mobile after his first stint as the Jaguars' defensive coordinator in 2016 and 2017 Wommack is coming home to the program after spending three years as linebackers coach at Indiana University, including serving as the Hoosiers' defensive coordinator his final two seasons. Last year he was named a finalist for the award given to the top NCAA Football Bowl Subdivision assistant coach: The Broyles Award. Wommack was one of five finalists for this prestigious award, after his efforts helped Indiana University post a 6-2 mark overall on the way to finishing

12th in the final Associated Press poll and earning an invitation to the Outback Bowl.

Kane and Melissa have three sons, Asher, Tatum and Jones, and they are all thrilled to be back in Mobile!



# **BUSINESS INSIGHT**



A few years ago, I went through the Emerging Leaders program with the Small Business Administration. This program is meant to set you up for growing your business. It helps you understand everything from reading balance sheets, to working on larger government contracts. But the one exercise that I got the most out of was writing a 5-year plan.

I won't lie, I was really struggling with the exercise. Try it, and you'll find that it is not as easy as you might think. But I talked to a friend who had gone through the program the year before and he helped me by explaining it like this:

Imagine your life in 5 years. What do you want that to be like? Think about every aspect of your life. What time will you wake up? Where will you be living? What will you do first thing when you get out of bed? What kind of car will you drive to work? How much money will you be making? When you get to work what kind of activities will you work on? Is there a particular type of client you will be working with?

All of these questions have to be answered before you can answer what is expected in the exercise. If you are making x dollars per year, how many employees will you need to have in order to make that salary? What will the annual revenue of the business need to be? Break down the different areas of your business. Do you have different departments? Which ones need to grow in order to get you there? What kind of support staff do you need to keep the small stuff from burying you? Will you need a full-time bookkeeper, administrative assistant, or sales team?

It's no secret that things are rough right now, but there is money to be made. Unlike when the economy is flourishing, right now you really have to work for each new deal. You have to really focus on reaching your client base and increasing your business. You can do it. You might have to change a few things in your business or take some chances in areas that you've not had to before. But that is business, there are always risks. Just try and think through the different scenarios and keep a close eye on progress so you are not sunk.

I'd like to assign you some homework. Don't dismiss this. It is extremely important for a business owner to have a plan. Yes, the plan may change, or you may have to pivot. But with a plan, you have a direction to head, and making decisions becomes easier because you can ask yourself if this furthers your progress on achieving the goals in your plan. So, I want you to take an hour sometime in the next couple of days and write down what you want your life to look like in 5 years. # REAL ESTATE CORNER BYRON SIVAK

The **Tillman's Corner Walmart** reopened around the middle of last month after closing for roughly two weeks due to a fire set inside the property. According to media reports, investigators believe three individuals were responsible for the arson that occurred inside Walmart retail stores not only in Mobile, but also in Gulfport and Biloxi, Mississippi. "Our focus right now is the safety of our associates and customers. We will continue to work closely with law enforcement officials to resolve this as quickly as possible," Walmart's corporate office said in a prepared statement. FBI offices in Mobile and Jackson, Mississippi are reportedly working together to track down and apprehend those responsible.

Last month Roswell, Georgia-based Forrest Street Partners announced the acquisition of Johnny's RV Resort located at 6171 US-90 in Theodore and now reportedly owns two RV parks in the state, both located in lower Alabama. The Johnny's RV Resort currently has 165 sites and seven cabins, and the boutique real estate firm plans to invest in the park by adding five more cabins and 15 additional RV spaces. Construction began in June on new cabins and plans are in place for a new bathhouse, entry and exit gates, updated security systems and internet - all under the umbrella of new branding. The new site will reportedly still cater to short-term and long-term campers who work locally. Forrest Street also owns Bay Palms RV Resort, which serves seasonal visitors to Dauphin Island.

The West Mobile office of Berkshire Hathaway Cooper & Co., Inc. recently announced that a private investor bought some 14 lots in Unit 3 and Phase IV of Deerfield Estates in Irvington, situated due south of Theodore, for \$154,000. Tony Cooper and David Cooper of the company's commercial division represented the sellers. Sherri Jones of Berkshire Hathaway worked for the buyer in the transaction.

John M. Delchamps with the Merrill P Thomas Co., Inc. recently represented local investors in the purchase of a mixed use retail and commercial property located at 6414 Hillcrest Park Court in West Mobile. The 7,700 square foot building reportedly sold for \$290,000 and is currently 100 percent leased. Kelly Cummings with The Cummings Company worked for the buyers in the transaction.

Last month, well known West Mobile-based insurance and real estate brokerage, **The Paul Carter Agency**, completed a move to a new **2,100 square foot** office space located at **4266 Cottage Hill Rd**., located directly across from Cottage Hill Baptist Church. Established nearly 30 years ago, the company employs six agents locally.

# COASTAL 150 UPDATE

# New Outlook for an Infrastructure Package in Washington, But Still Cloudy

This week, President Biden and a group of centrist senators agreed to a roughly \$1 trillion infrastructure plan, securing a long-sought bipartisan deal on overhauling the nation's transportation, water and broadband infrastructure that lawmakers and the White House will now attempt to shepherd through a closely-divided Capitol Hill.

Under the framework, the bipartisan package, led by Sens. Kyrsten Sinema (D-Ariz.) and Rob Portman (R-Ohio), would include more than \$550 billion in new spending on roads, bridges and other traditional infrastructure projects. The White House and the bipartisan group have spent this past few weeks negotiating on how to pay for the package. Senate Republicans have said they will not touch the corporate tax rate, while Biden and Senate Democrats have rejected proposals to index the gas tax and enact fees for electric vehicles.

The deal includes \$559 billion in new spending for a total of \$1.2 trillion over eight years. But that amount is still substantially smaller than what many Democrats want and many progressives are calling foul. Biden has outlined a \$2.3 trillion jobs plan and a \$1.8 trillion families plan, while the bipartisan group plan is more tightly focused on more traditional infrastructure like roads, bridges and broadband.

Shortly after the White House announcement, Speaker Nancy Pelosi (D-Calif.) said the House will not vote on a bipartisan infrastructure deal until the Senate also passes a larger package of Democratic priorities that can evade a GOP filibuster.


Pelosi's remarks are meant to pacify progressives nervous that the bipartisan deal could negate efforts to approve a much larger package of priorities through special budget rules in the Senate that would allow the measure to avoid a GOP filibuster. Also the speaker is sending a signal to two centrist Democrats Joe Manchin (D-WV) and Kyrsten Sinema (D-AZ) of the Senate: If they want a bipartisan deal, they need to endorse the party's Democrats-only infrastructure bill that could top \$5 trillion, in addition to the \$1 trillion spent on on roads and bridges.

If some Democrats ultimately oppose the package, Republicans would need to sign on in larger numbers to ensure its passage. A group of 21 Senators, including 11 Republicans, have previously lent their support to the bipartisan efforts, though some of those lawmakers said Thursday they were still reviewing details of the emerging deal.

Sen. Rob Portman (R., Ohio), the lead Republican negotiator, spoke with Senate Minority Leader Mitch McConnell (R., Ky.) and other top Republicans to discuss the agreement. Mr. Portman said Mr. McConnell told him he was open minded about the framework. Sen. John Thune (R., S.D.), the No. 2 Senate Republican, said the plan's funding for transit was potentially a problem for him. He said he wasn't yet sure if the plan would win 60 votes and would need to discuss it with other Republicans.

This Bipartisan package might just be too bipartisan for some on the Progressive Left and some Republicans unwilling to agree to the new spending, stay tuned.




