Your Excellency,

We, the undersigned, are a group of individuals and organizations that advocate for human rights and religious freedom around the world. We represent diverse religious and ethnic backgrounds but are united in our goal of promoting freedom of religion or belief for all. We are writing to you to express our concern regarding the safety of US citizen Jeffery Ray Woodke, who was kidnapped in Niger.

Mr. Woodke, an American Missionary from California who has more than two decades of experience working in Niger, was kidnapped by unknown gunmen who were suspected of being Islamic Militants on the evening of October 14, 2016. Villagers trailed the kidnappers and reported that they were near the border with Mali at last report.

Mr. Woodke is one of the 66 Americans who are currently being held against their will in 16 countries around the world.¹ Needless to say we are concerned about the welfare of this gentleman.

Recent information provided to his family suggests that he may be in the custody of Jama'at Nasr al-Islam wal Muslimin (JNIM) which is a known affiliate of al-Qaeda operating in West Africa specifically in Mali. We appreciate the efforts by the Government of Mali to have the main Islamic body begin negotiations² with JNIM to bring peace to the country.
