## **CRITERIA FOR SELECTION**

### **Mary C. Williams Memorial Volunteer of the Year**

Mary Williams volunteered weekly at the Kerrville Area Chamber of Commerce from 1992 to 1997, meeting the public, making phone calls, answering mail, training other volunteers and doing general office work. Additionally, she served as a volunteer at the VA Hospital, providing many services to the patients there. The winner of this award will be a person that exemplifies the Volunteer Spirit in their involvement in the Kerrville area.

#### Criteria:

1. Number of hours contributed as a volunteer (20%)
2. Variety of places this person has volunteered (15%)
3. Volunteer services provided (25%)
4. Special contribution this person has made through their volunteer commitment (25%)
5. How did the nominee's volunteer service positively impact the business community? (15%)

#### Nomination:

1. Nominee must be a Chamber member or work for a Chamber member.
2. Nominations are only accepted from Chamber members.

## **CRITERIA FOR SELECTION Business of the Year Award**

4. You are permitted to nominate your own business.
