Applicant must submit, in her/his own words, two essays between 350 and 500 words each describing 1) why he/she wants to continue their education beyond high school, and 2) the effect their parent's membership in AFSCME has had on their family, and on them at a personal level. Attach separate sheets for statements. Statements must be typed or printed and returned with the application. The applicant's name should appear at the bottom of each page of the statements.

About the Scholarships

The AFSCME Ohio Council 8 Scholarship Program was created in 1982 to provide financial assistance to the children of Ohio Council 8 members to attend a four-year accredited college or university. The scholarships, two \$2,500-a-year grants for four years, are awarded annually to two different recipients, one male and one female, based on the applicant's need, academic history and higher education goals. Scholarship applications are reviewed by the union's executive board, which will award the two scholarships no later than June 30, 2022.

Cheryl Keeler and Doug Moore

Cheryl Keller is a native of Columbus who graduated from Central High School and later graduated from the Ohio State University with a degree in English and literature.



Cheryl started her 18-year Ohio Council 8 career in 1987 as a legal secretary and five years later, became the Legal Department's Supervisor/Paralegal.

In 1994, she joined the Columbus Region as a Staff Representative. In 2000, she was appointed Columbus Regional Director, a position she held until retiring in 2005.

Cheryl lives in Columbus and is still active in the community as past president of the Second Wind Lung Transplant Association and is a consultant for Council 8 staff.

Doug Moore's roots in the labor movement run deep. After graduating from Bluefield State College in 1968 with a degree in education, Moore taught school for two years before bringing his teaching skills to the Ohio Laborer's Training and Upgrading Program.

Doug's association with AFSCME Ohio Council 8 began in 1980, when he was hired as a code enforcement officer by the City of Columbus. He quickly worked his way up through the ranks, serving as a steward, chief steward, executive board member, vice president, and in 1992, he was elected President of AFSCME Local 1632 representing Columbus city workers. Moore was elected as a Columbus Regional Vice President the same year and served on the union's executive board until he retired in 2015.

Over the years, he has provided the energy and vision that enabled Local 1632 to lead the way with innovative programs like the Quality of Working Life program, grievance mediation, and interest-based bargaining.

In addition he was active with the Ohio AFL-CIO, the Coalition of Black Trade unionists, and the A. Philip Randolph Institute.

In retirement he is still active in the Columbus community and his church.



Guidelines

Please Review the Following Before Submitting an Application

ELIGIBILITY

An applicant's parent must be an AFSCME Ohio Council 8 affiliated local union member who has been in good standing for at least one (1) calendar year prior to May 6, 2022.

An applicant must graduate from high school in the year in which application for the scholarship is made.

An applicant must attend a four (4) year accredited college or university as a full-time student.

Children of members of the AFSCME Ohio Council 8 Executive Board or of any staff member of the Council are not eligible for participation in the scholarship program.

Applications must be **postmarked** no later than **Monday, May 6, 2022**. Applications which are incomplete, or which are postmarked after the specified date, will be ineligible for consideration.

APPLICATION REQUIREMENTS

An applicant must submit with his/her application two essays, each between 350 and 500 words in length. One essay is to describe why the applicant wants to attend college; the other is to describe the effect their parent's membership in AFSCME has had on their family and on them at a personal level. Content, grammar, spelling and appearance will be considered.

An applicant must submit his/her high school transcript and a written recommendation from a high school guidance counselor or teacher who has personal knowledge of the applicant.

DISBURSEMENT OF FUNDS

Scholarship funds will be pro-rated in accordance with the college or university's academic year. Applicants awarded a scholarship will be provided with detailed information as to the requirements for proof of tuition fee payment and full-time status at the time the scholarship award is made.

Scholarship funds will be paid for any quarter or semester during which the student is enrolled full-time and has submitted proof of out-of-pocket education expenses. Reimbursable education expenses are limited to tuition or other university/college fees, expenses for textbooks and expenses for room and board, including any university/college-sponsored meal programs. Proof of out-of-pocket education expenses must be provided, and may include payment toward a student loan(s). Scholarship funds will not be paid for any quarter or semester in which a student has no out-of-pocket education expenses due to the receipt of other grants, scholarships or tuition waivers.

If, during the four-year eligibility period, a student leaves school for any quarter or semester except summer, the scholarship will be terminated for the period the individual is not a student or is a part-time student.

The scholarship will be terminated at any point the student's parent ceases to be a member in good standing of the union for any reason, except retirement or death. The scholarship will be terminated if the student fails to maintain a passing grade point average.

Termination will be effective with the beginning of the next semester or quarter following the date the parent terminated union membership.
